Trustee Areas Description

Trustee Area 1: The region bounded and described as follows: Beginning at the intersection of the western district boundary and Highway 101 (El Camino Real), the boundary runs east along Highway 101 to its intersection with Fairview Ave, then north along N Fairview Ave to its intersection with Cathedral Oaks Rd, then east along Cathedral Oaks Rd to its intersection with N Patterson Ave, then north along N Patterson Ave to its intersection with La Josa Rd, then the north along La Josa Rd to its intersection with parcel 067-010-011, then west along the edge of parcels 067-010-011 and 067-010-012 to its intersection with San Jose Creek, then north along San Jose Creek to its intersection with parcel 153-310-020, then east along the northern edge of parcels 153-320-026, 153-320-021, 153-320-027 and 153-31-019 and then continuing east along parcels lines to parcel 153-340-057 and to the district, then generally north, then west, then south along the district boundary to the point of origin.

Trustee Area 2: The region bounded and described as follows: Beginning at the intersection of Cathedral Oaks Rd and N Patterson Ave, the boundary runs north along N Patterson Ave to its intersection with La Josa Rd, then the north along La Josa Rd to its intersection with parcel 067-010-011, then west along the edge of parcels 067-010-011 and 067-010-012 to its intersection with San Jose Creek, then north along San Jose Creek to its intersection with parcel 153-310-020, then east along the northern edge of parcels 153-320-026, 153-320-021, 153-320-027 and 153-31-019 and then continuing east along parcels lines to parcel 153-340-057 and to the district, then generally south, then west, then south along the district boundary to its intersection with Vieja Dr, then west along Vieja Dr to its end and the line continues to its intersection with that line and Atascadero Creek, then west along Atascadero Creek to its intersection with S Patterson Ave, then north along S Patterson Ave to the point of origin.

Trustee Area 3: The region bounded and described as follows: Beginning at the intersection of the district boundary and Vieja Dr, the boundary runs west along Vieja Dr to its end and the line continues to its intersection with that line and Atascadero Creek, then west along Atascadero Creek to its intersection with S Patterson Ave, then north along S Patterson Ave to its intersection with Cathedral Oaks Rd, then west along Cathedral Oaks Rd to its intersection with N Fairview Ave, then south along N Fairview Ave to its intersection with Hollister Ave, then west along Hollister Ave to its intersection with S Los Carneros Rd, then south along S Los Carneros Rd to its intersection with El Colegio Rd, then east along El Colegio Rd to its intersection with parcel 073-130-001, then south along the western edge of parcel 073-130-001 and along that line to the district boundary, then generally east and north along the district boundary to the point of origin.

Trustee Area 4: The region bounded and described as follows: Beginning at the intersection of S Fairview Ave and Highway 101, the boundary runs south along S Fairview Ave to its intersection with Hollister Ave, then west along Hollister Ave to its intersection with S Los Carneros Rd, then south along S Los Carneros Rd to its intersection with El Colegio Rd, then west along El Colegio Rd to its end and continues along that line to its intersection with the Devereux Slough, then northwest across Devereux Slough to its intersection with the walking path between Marymount Way and Sea Cove Lane, then west along the walking path between Marymount Way to its intersection with Sea Cove Ln, then south along Sea Cove Ln to its intersection with Pacific Coast Dr, then west along Pacific Coast Dr to its intersection with Coral Way, then northeast and east along Coral Way to its intersection with Ocean Walk Ln, then north along Ocean Walk Ln to its intersection with the northeast corner of parcel 073-090-069, then southeast and south along the edge of parcels 073-090-069 and 073-090-075, then west along the edge of parcels 079-210-019 and 079-210-024, then north and west along parcel 079-210-051, then north and west along

Trustee Area 5: The region bounded and described as follows: Beginning at the intersection of the western district boundary and Highway 101, the boundary runs generally south and east along the district boundary to its intersection with parcel 073-450-003, then north along the western edge of parcel 073-450-003 to its intersection with El Colegio Rd then west along El Colegio Rd to its end and continues along that line to its intersection with the Devereux Slough, then northwest across Devereux Slough to its intersection with the walking path between Marymount Way and Sea Cove Lane, then west along the walking path between Marymount Way to its intersection with Sea Cove Ln, then south along Sea Cove Ln to its intersection with Pacific Coast Dr, then west along Pacific Coast Dr to its intersection with Coral Way, then northeast and east along Coral Way to its intersection with Ocean Walk Ln, then north along Ocean Walk Ln to its intersection with the northeast corner of parcel 073-090-069, then southeast and south along the edge of parcels 073-090-069 and 073-090-075, then west along the edge of parcels 079-210-019 and 079-210-024, then north and west along parcel 079-210-051, then north and west along parcels 079-210-024 and 079-210-069, then north along parcel 079-210-059 to its intersection with Hollister Ave, then west along Hollister Ave to its intersection with Cathedral Oaks Rd, then north along Cathedral Oaks Rd to its intersection with Highway 101, then west along Highway 101 to the point of origin.
